- Food vendors shall comply with all Health Department regulations.

All vehicles must be out of the event sites by 9:00AM. Breakdown is prohibited prior to the scheduled closing of the events. **No Exceptions!**

The undersigned ("Vendor") hereby agrees that Vendors participation in the Old Miner's Days events shall be in full compliance with all guidelines, laws, and rules established by any governmental agency or other body having jurisdiction over Vendors activities in the events. Vendor agrees to assume all responsibility and expense, including but not limited to retention and payment of compensation to any sub-contractor and/or employee, and payment of applicable taxes, in conjunction with Vendors participation in the event. In consideration of acceptance by the Old Miner's Association to participate in any event, Vendor agrees to defend, indemnify, and hold harmless, the Old Miner's Association, its Officers and volunteers, from any and all liability, including but not limited to injuries, damages, theft, demands for damages, judgments, loss of service, claims, actions or causes of action, including subrogation, re-imbusement of attorney fees, costs or expenses of any kind, (a "Claim") arising out of Vendors participation in the Event, whether such Claim is initiated by Vendor or any other person, entity, or organization.
